Section 1

This section explains the process of the financial requirements for entry to Buckland.

1. When the organisation believes it can satisfy the requirements of a potential resident, initial contact will be made by phone, and subject to agreement.
2. An "Offer & Acceptance" form will be forwarded indicating the style of accommodation offers, unit number, garage availability, special inclusions (if any) and the total costs involved.
3. A period of seven (7) days will be allowed for the return of the Offer & Acceptance form and with the acceptance, a non-refundable deposit amount of \$500.00 will be required.
4. Within four weeks (28 days) of the date of the acceptance a further sum representing the balance (after deposit) of ten percent (10%) of the total costs involved will be required. If payment of this amount by the due date is not made then it will be presumed that the potential resident does not wish to complete the transaction and the offer of accommodation will be withdrawn.
5. Within a further period of a maximum of six weeks (70 days from acceptance date) the remaining balance of the total costs will be required.
6. Following final settlement, a formal agreement to occupy (in the same format as the agreement included with this information package) will be drawn up and you will be required to sign this document.
7. Actual occupation of the accommodation offered may be negotiated prior to, on or after, settlement, however, for the purposes of the payment of recurrent charges (maintenance fees) the deemed date of occupation will be no later than the stipulated final settlement date.
8. It will be a requirement that the payment of recurrent charges is arranged by way of a periodical payment / bank transfer direct to the organisation's bank account.
9. Should a potential resident experience or anticipate any problems whatsoever during the process of entry to Buckland, immediate contact with the organisation is required.
